

# 2018 Annual Property Investor Survey Full Terms and Conditions

## Terms and Conditions of Competition Entry

### PART A – GENERAL TERMS

1. Information on how to enter the 2018 Annual Property Investor Survey competition (Competition) and prize details form part of these terms and conditions of entry.
2. Participation in the Competition constitutes acceptance of these terms and conditions of entry. A participant of the Competition (Entrant) must comply with these terms and conditions of entry to be valid.

### PART D – WHO CAN ENTER

5. Entry is open to residents of Australia over the age of 18. Employees of Momentum Wealth and affiliates are exempt from this competition and not eligible for any prize. The Promoter reserves the right to refuse participation of any one individual and is thereby not obliged to provide details as to the reason for their decision.
6. The Competition commences Wednesday 17th October 2018 and entries close at noon Australian Western Standard Time (AWST) on Friday 30th November 2018.
7. To complete the survey, an Entrant must answer all Survey questions including (but not limited to) the following: In 30 words or less, tell us what your ideal retirement lifestyle is.
8. Entries must not contain any offensive or inappropriate content. Entrants confirm and promise that their entry is an original and unpublished work and does not infringe the rights of any other person.
